# 1. CALL TO ORDER

- 1.5 School Spotlight New Horizons Principal Ted Zarowny showed a video he created for the celebration of their 20 years of success on Feb. 24. The school opened in 1995 with 79 students (there are now 250) and offers instruction to academically gifted students, K through Gr. 9. The pride of the staff and students was evident in the presentation, which featured class photos going back all their 20 years.
- 1.6 Education Research Update FFCA's Chris Shaw (PE teacher at their Southeast Elementary Campus) and Dr. Larry Katz (Professor and Director of the Sport Technology Research Laboratory, Faculty of Kinesiology, U. of Calgary) presented their joint research. Dr. Katz is also co-founder of the Canadian Centre for Exergaming Research and Director of the Centre for Video and Performance Analysis. Their research East Meets West: A Comparison of Two Different Philosophical Approaches to Instruction compares ball-throwing instruction through the Teaching Games for Understanding (TGfU) method, which is used in the west, to the eastern Zen philosophy and concludes that combining the 2 methods results in optimal learning.

#### 2. COMMITTEE REPORTS

- 2.1 Charter Board Directors' Report No meeting yesterday (no report).
- 2.2 Strategic Planning Committee This work began last October and identified goals in 3 areas that will provide a framework for our planning: Communication, TAAPCS (ideal state) and the Research Mandate. The process will resume in the fall.
- 2.3 Communication Strategists' Report (See handout.) Marie Rajik and Natalie Sigalet from Hill & Knowlton gave us their analysis of the demographic conditions in Alberta and how they have influenced the political events of the recent past. They provided information related to the new government's priorities, and advice on how to approach them (Government Relations 101 Keys to Successful Lobbying).
- 2.4 Superintendents' Report Discussion topics included admission procedures, the political environment, communication strategies, creating more opportunities for shared services, elected Boards/voter eligibility, and the development of policy around the new research mandate.

**Discussion of "Governance" at the Board and Association Levels** – Presented by Becky Kallal. This item emerged from the strategic plan goal of strengthening TAAPCS (ideal state); various topics including our bylaws, term limits, code of conduct, policy structure, committees, number/timing of meetings, role descriptions, and the composition of our Board were discussed.
